DUTIES OF THE REIGNING MONARCH(S)

Policy:

1. The Current Reigning Monarch(s) shall uphold and promote the Aims and Objectives of the Society and shall act as goodwill ambassadors to the Society, to the 2SLGBTQIA+ Community, and the Community-at-large.
2. The Current Reigning Monarch(s) shall reign over their house or “kingdom” in perpetuity.
3. The Current Reigning Monarch(s) shall establish a set of priorities to be presented to the Board of Directors, for approval, at the first regularly scheduled meeting following the AGM. These priorities shall be the basis of their activities to be undertaken during their reign.
4. The Current Reigning Monarch(s) shall host a minimum of one (1) Community-at-large meeting during their reign dedicated to describing and explaining their priorities as well as to promote the Aims and Objectives of the Society.
5. The Current Reigning Monarch(s) are responsible, with the exception of the Annual Ball, for organizing all fundraising initiatives of the SOMS.
6. The Current Reining Monarch(s), barring any unforeseen circumstances shall be financially capable to commit time to attend three (3) Coronations each, anywhere in the International Court System.
7. The Current Reigning Monarch(s) shall, within three (3) months into their reign, be responsible for appointing the Ball Coordinator, pending Board approval.
8. The Current Reining Monarch(s) shall be responsible for choosing the recipient(s) of the annual Citizen of the Year Award, the Community Spirit Award, and the Stephanie Lane-Barr Lifetime Achievement Award.
9. The Current Reining Monarch(s) shall perform all other duties that the Board of Directors determines from time to time by resolution or By-Law.
10. The Current Reigning Monarch(s) must be residents of Manitoba, as defined by Provincial Government’s residency criteria until completion of all reign requirements.
